A RESOLUTION TO EXPRESS AND REAFFIRM THE COUNCIL'S INTENT TO INCLUDE IN THE CITY OF ATLANTA'S 2002 LEGISLATIVE PACKAGE THE VARIOUS PIECES OF LEGISLATION LISTED BELOW; AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta City Council approved and the Mayor adopted Resolution 01-R-0964; A RESOLUTION FOR INCLUSION IN THE 2002 LEGISLATIVE PACKAGE REQUESTING THE GEORGIA GENERAL ASSEMBLY TO STUDY ALTERNATIVE MEANS OF FUNDING EDUCATION IN THE STATE OF GEORGIA IN ORDER TO RELIEVE THE LOCAL PROPERTY BURDEN ON SENIOR CITIZENS OF GEORGIA, and

WHEREAS, the Atlanta City Council approved and the Mayor adopted Resolution 01-R-1442; A RESOLUTION TO INCLUDE IN THE CITY OF ATLANTA'S 2002 LEGISLATIVE PACKAGE, A REQUEST THAT THE GENERAL ASSEMBLY ENACT LEGISLATION WHICH WOULD EXCLUDE THE MARTA TAX FROM THE STATE IMPOSED 2% LOCAL OPTION SALES TAX CAP FOR THE PURPOSE OF A SPLOST; AND FOR OTHER PURPOSES, and

WHEREAS, the Atlanta City Council approved and the Mayor adopted Resolution 01-R-1709; A RESOLUTION TO INCLUDE IN THE CITY OF ATLANTA'S 2002 LEGISLATIVE PACKAGE, A REQUEST THAT THE GENERAL ASSEMBLY ENACT AMENDMENTS TO THE LAW GOVERNING THE PEACE OFFICER'S ANNUITY AND BENEFIT FUND (O.C.G.A.47-17-1 ET. SEQ.) SO AS TO ALLOW RETIRED AFRICAN-AMERICAN PEACE OFFICERS WHO PRIOR TO 1976 WERE EXCLUDED FROM BEING MEMBERS BECAUSE OF THEIR RACE, TO BECOME MEMBERS OF SAIS FUND; AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta City Council approved and the Mayor adopted Resolution 01-R-1791; A RESOLUTION AUTHORIZING THE CITY OF ATLANTA TO INCLUDE IN ITS 2002 LEGISLATIVE PACKAGE A REQUEST FOR THE GEORGIA STATE LEGISLATURE TO INCREASE THE MONTHLY EMERGENCY 911 (E-911) SURCHARGE OF \$1.50 FOR WIRE TELEPHONE SUBSCRIBERS AND \$1.00 FOR WIRELESS TELEPHONE SUBSCRIBERS TO \$1.92 AND \$1.42 RESPECTIVELY; AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta City Council approved and the Mayor adopted Resolution 01-R-1860; A RESOLUTION TO INCLUDE IN THE CITY'S 2002 LEGISLATIVE PACKAGE, A CHARTER AMENDMENT ALLOWING THE IMPOSITION OF AN EXCISE TAX OF FIVE PERCENT ON COMMERCIAL AREA, SPACE GARAGE, PARKING STRUCTURE, OR OTHER FACILITY, UPON OR IN WHICH MOTOR VEHICLES ARE PARKED, STORED, OR HOUSED WITHIN THE CORPORATE CITY LIMITS OF THE CITY OF ATLANTA; AND FOR OTHER PURPOSES.
