AN ORDINANCE TO ANTICIPATE AND APPROPRIATE GRANT FUNDS IN THE AMOUNT OF \$41,250,000.00 FROM THE TRANSPORTATION SECURITY ADMINISTRATION FOR FISCAL YEARS 2004 AND 2005 PURSUANT TO THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY AND THE TRANSPORTATION SECURITY ADMINISTRATION DATED FEBRUARY 17, 2004, WHICH MEMORANDUM OF AGREEMENT WAS AUTHORIZED BY THE CITY COUNCIL BY RESOLUTION 03-R-0384 ON JULY 21, 2003 AND APPROVED BY THE MAYOR ON JULY 29, 2003, TO REIMBURSE THE CITY FOR ALLOWABLE COSTS OF THE AUTOMATED HOLD BAGGAGE SCREENING PROJECT AT THE HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT AND FOR OTHER PURPOSES.

**WHEREAS**, the City of Atlanta owns and operates the Hartsfield-Jackson Atlanta International Airport ("Airport"); and

**WHEREAS**, the City of Atlanta entered into a Memorandum of Agreement ("MOA") with the Transportation Security Administration ("TSA") on February 17, 2004, pursuant to Resolution 03-R-0384 adopted by the City Council on July 21, 2003 and approved by the Mayor on July 29, 2003; and

**WHEREAS**, the TSA has announced its intentions, in accordance with the provisions of Section 367, Division I, of the Department of Transportation and Related Agencies Appropriations Act, 2003, Pub. L. 108-7, 117 Stat. 423 and the Memorandum of Agreement ("MOA") between the City of Atlanta and the TSA to reimburse the City of Atlanta for allowable costs of the Automated Hold Baggage Screening Project at the Airport in the maximum amount of \$93,750,000.00 over a four (4) year period; and

**WHEREAS**, the TSA provided an Amendment of Solicitation/Modification of Contract to the City of Atlanta, dated July 22, 2004, authorizing the funding allotment for Federal Fiscal Year 2004 of \$15,000,000.00; and

**WHEREAS**, the TSA provided an Amendment of Solicitation/Modification of Contract to the City of Atlanta, dated February 21, 2005, authorizing the funding allotment for Federal Fiscal Year 2005 of \$26,250,000.00; and

**NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA** as follows:

**Section 1:** That the 2005 [2004 Airport Renewal & Extension Fund (2H21)] Budget be, and is hereby, amended as follows:
